**PRINCIPAL ACTIVITIES**

The principal activity of the company is to manage, maintain and administer land and buildings at 62-72 (even numbers only) Keswick House, Eastbury Way, Swindon. The company is a "Right To Manage" (RTM) company operating under the standard RTM Articles of Association as determined by the Commonhold and Leasehold Reform Act 2002.

**BUSINESS REVIEW**

During the year the company faced challenges presented by Covid-19 restrictions. The members took on the cleaners' duties for the communal areas to avoid unnecessary social contact and held a meeting on 17 April 2021 at which the service charges for 2021/22 were agreed.

**SERVICE CHARGE ACCOUNTS**


